

**MINISCEONGO PARK
FINAL SUPPLEMENTAL ENVIRONMENTAL IMPACT STATEMENT (FSEIS)**

Project Description: The development, Minisceongo Park, would consist of 200 multifamily dwellings and no more than 270,850 square feet of commercial space. The multifamily development would be located in the Town of Ramapo, along with 16,850 square feet of commercial space for occupancy by two restaurants, a bank and a deli/coffee shop. Two commercial buildings consisting of 254,000 gross square feet of commercial space, would be constructed in Haverstraw.

Location: The project site consists of approximately 53.3 acres that straddle the Town of Haverstraw and Town of Ramapo boundary. The site maintains frontage on the north side of U.S. Route 202, and is located just west of the Palisades Interstate Parkway in Rockland County, New York.
